Dear Parents/Carers

We are participating this year in the Fiver Challenge, which is a national competition for young people aged from 5 – 11 years. This challenge is free and run by Young Enterprise ([www.fiverchallenge.org.uk](http://www.fiverchallenge.org.uk)). It is the UK's leading enterprise and financial education charity which aims to bring learning to life and help encourage future aspirations in young people.

Pupils are pledged with an amount from the Fiver Challenge organisation and have one month to set up a mini business and create a product or service they can then sell or deliver at a profit. Pupils will then decide how to spend or donate their profit. It is going to be a fantastic opportunity for Year 6 to develop their skills at working in a team as well as developing an appreciation of how to manage their own finances.

In the apprentice-style competition, there will be opportunities for children (and their business) to compete nationally and this will involve them designing their own company logos and filming their own 60 second pitches on their products. If selected, the group's logos and/or pitch will be submitted to the Fiver Challenge and may feature on the Fiver Challenge website. If a group from Sandgate were to win a mini-challenge, that group would receive a £50 Amazon voucher to split between them. Larger prizes may be won at the end of the four weeks, depending on the success of the group's business. **Please could you complete the attached permission form as it will enable your child to be filmed for the challenges and, potentially, photographed if they were lucky enough to win a prize!**

The Fiver Challenge will take place for 4 weeks from **Monday 3<sup>rd</sup> - Friday 28<sup>th</sup> June**. Any support and encouragement you can give your child during this activity would really be appreciated.
